That TIMOTHY RYAN HOOD on or about March 28, 2022, through May 2, 2025, in Jefferson County, West Virginia, did unlawfully, feloniously and knowingly acquire or obtain possession of a controlled substance, to wit: an amount of Fentanyl held as evidence in the custody of the Ranson City Police Department from Incident Number 21RN07036; by misrepresentation, fraud, forgery, theft, deception, or subterfuge, in violation of Chapter 60A, Article 4, Section 403(a)(3) of the Code of West Virginia, as amended, against the peace and dignity of the State.

COUNT 2  
OBTAINING A CONTROLLED SUBSTANCE BY THEFT

That TIMOTHY RYAN HOOD on or about October 2, 2024, through December 23, 2024, in Jefferson County, West Virginia, did unlawfully, feloniously and knowingly acquire or obtain possession of a controlled substance, to wit: an amount of Cocaine held as evidence in the custody of the Ranson City Police Department from Incident Number 24RN09177, by misrepresentation, fraud, forgery, theft, deception, or subterfuge, in violation of Chapter 60A, Article 4, Section 403(a)(3) of the Code of West Virginia, as amended, against the peace and dignity of the State.
